- The Carpentry Teacher who accidentally burned a student was reinstated

- The teacher who was horseplaying with a student was issued a 3-day suspension.
- HR has been involved with one of the APs at Platt interfering with union business and the intimidation of our members. This seems to have been handled.
- The SVFT had a very productive meeting with Dr. St.Onge and Dr. Menounos on the Teacher Evaluation and DH evaluation. Waiting to receive a summary of the meeting and where we can come to a compromise. We will be presenting our concerns and suggestions for the dispute resolution process. As it currently stands they have agreed to dispute-resolution on all areas of the document. Bob will share the summary as soon as he can.

## Ed Leavy's President's Report

Ed shared the following:

- The SEBAC "Gang of 15" (just the voting members) continues to meet. Last week in caucus, voting members rejected several State proposals such as delays and reductions in COLA. We also decided not to vote to have official discussions yet, because the Governor's comments that "concession discussions are underway" is not a message we can accept.
- During the last meeting, the State and SEBAC agreed on a set of principles which include layoff protection.
- Ed discussed the OFA pension fact sheet that was included in the rep packet. Feel free to share with members.
- January 19th is an Alliance to Reclaim Our Schools Day of Action. It is also AFT-CT's Legislature 101 Training. Rumor is that the budget will contain the closing of two schools, with the money going to increased financing of charter schools. We may want to design a letter-writing campaign to legislators about maintaining or increasing funding to the system.
- The LPN instructors still have not had their close-out meeting, nor has one been scheduled. When I talked to Ben Barnes and Lisa Grasso-Egan yesterday, it was clear the delay is trying to prevent laying off any of the members (the State has committed to SEBAC not to have layoffs during negotiations). The LPN instructors are very impatient about the meeting, but there is no point in rushing into layoffs if they can be avoided.
- Mark Vincent has picked up the trumpet on the TRB issue again. It is insane to believe that any proposal with a fiscal note will pass during this session.
- Ed will be attending a workshop on managing student debt this weekend here at AFT-CT. He will be offering his own workshops after his training.
- The aviation program's tuition will be discussed at the next CTHSS board meeting
