- ALEKS MOU a clarification is being sent to all Administrators
- ADA accommodations are not being implemented at Windham or Ellis
- More and more teachers are being harassed by parents. When these issues are brought up to Admin there is little or no support usually referring it to another one of our members. Presently this is happening at O'Brien, Cheney, and Ellis.
- HR operates very differently than ever before. Now the school administrators are being told to do the investigations. HR reviews the case and assigns discipline. We grieve the discipline and hopefully get some movement. Principals are not relying Letters of Concern, Counseling, or Reprimand to our office. Sometimes I am not even aware of an investigation.
