Paul discussed the following:

- Degree Stipend reminder, Carla Kielbasinski will be sending an e-mail out in August containing that will explain what's needed. Tell members don't send anything beforehand, she is overseeing it now.
- TOY Banquet was held May 16th to honor all the winners as of June 7th I have not heard from Central Office when the District selection will take place but have asked.
- Tuition reimbursement deadline has passed for this year it was June 7th, anything processed now will be paid next year, and there were a lot of late submittals. The end of last week. Remind members two weeks before the class starts, or it slows the entire process down.
- Scholarship Committee met an awarded eight thousand-dollar scholarships and one five-hundred-dollar mini grant.
- Building Rep/Admin meetings for next year: Please pick ten dates and set them now, it's nice to have a record of starting the process.
- I would like to thank six of the departing reps for their time with us and wish them well.

Ed Leavy's President's Report

Ed shared the following::

- 1. The TRB Retiree healthcare bill passed. Once they are vested in SEBAC, over 300 of our members will have \$1000+ for their family instead of having it go to a retiree healthcare program they will never use
- 2. Other bills of note: the CTECS avoided changes for this year at least in our ability to determine that some students are not appropriate for our setting; we are now included on the manufacturing education task force; minimum wage and FMLA passed; the Janus legislation did not get a Senate vote
- 3. We will have 27 or so administrative transfers over the summer. That's a ton of transfers!
- 4. The Wilcox situation is devolving at an alarming rate. A staffer has filed a complaint with Levi Gillespie after a student wrote the n word on his whiteboard and showed it around, and the principal decided "he probably did not know it was offensive." There have been a number of racial incidents not being addressed by the administration.
