Ed Leavy's President's Report

Ed shared the following:

- 1. We are running into a Janus-related issue: we have a substitute who is a member and has been removed from the substitute list for allowing "an unsafe classroom environment." She has hired a lawyer for discriminatory practices. We therefore need to file a grievance on her behalf to avoid a DFR for failing to exhaust all contractual remedies. Because she is a member, we now will have to file a grievance for all these cases; if a non-member is terminated and we do not grieve it, we'll be running afoul of the Janus decision. As far as I know, we have never grieved a substitute being removed from the CTECS list before.
- 2. Our next contract meeting is 1/28. We will go over last time's proposals and discuss leadership's proposals. We will be sending out a member survey soon as well.
- 3. We were able to avoid a nonrenewal/layoff by having the teacher use his math cert after administrative transfer into an open position
- 4. Legislative session starts soon. State agencies may be facing cuts based on federal funding. We have a few other issues we will be focused on as well.
