### **Ed Leavy's President's Report**

Ed shared the following:

1. Seniority list has been received but has numerous mistakes. We will try to fix mistakes before posting. Most mistakes have to do with members who are now full-time and had previous part-time service.
2. Tonya Stout (PD consultant) will apparently be doing observations at Prince Tech. We need clarification about how central office will be handling the situation going forward.
3. The Contract committee meets the 19th. A survey will follow shortly after.
4. Ed is attending a SEBAC meeting with the Lamont administration to discuss "Silver Tsunami" in 2022. A meeting with CTECS leadership will follow.
5. The Hartford Courant op-ed under my name (listed as SVFT President) is getting a lot of traction. It's been reposted over a dozen times, including nationwide.
6. Legislative session started today. . The one bill we have to track for the SVFT is the elimination of our ability to reject special ed kids for any reason. There's a brief description of that in the newsletter.
7. Getting acting DHs paid is a continuing nightmare. It seems like the principals are not requesting the positions correctly, but still it should be handled soon, even though HR is

badly understaffed.
