Paul Angelucci's President's/Vice President's Report:

- Scholarship committee awarded nine-one thousand-dollar scholarships and one-thousand-dollar mini grant.
- Degree stipend is on hold until our contract is settled. I spoke with Carla Kielabelinski the process will be the same and an e-mail will go out this summer for new members and existing members who furthered their education. Tell members not to reach out to her until she sends the e-mail request.
- Labor Management took place on the 25th of May. The minutes are in the newsletter. I would like to thank the outgoing members Lisa Higgins of Prince, Angela Ocascio from Windham our rep and Tommy Viola from Platt- they all did a great job!
- Building Rep/Admin meetings for next year pick ten dates now and send a request. It is the best way and this is a Superintendent directive.
- Tuition reimbursement process remains the same, they will be paid out in the order in which they are received.
- Math Coach/Program Coordinator, as per our conversation with the assistant Superintendent there is no math coach position yet. The Program Coordinator is being written up and will be a stipend position. This started with Dr. Menounos describing the duties etc. at a board meeting.
- SEBAC Update, the legislative session closes at midnight today there have been no talks of raises to date. The funds from the Recovery Act that deals with hazard pay is still in the preliminary stages and there has been no further discussion.
- Summer School, a quick update where we are right now and the process it took to get here: postings should be going up soon if not already up. Don't take a job until you know what you are being paid and it is in writing.
- SEBAC ends tomorrow.

- Summer School- they are looking for more money to pay these teachers.
- Two sessions on negotiations. July 9th-small room meeting.
- We will be hiring Spanish teachers or DSAP teachers.
- 1.6 Billion is allocated to frontline workers. No formula how it will be distributed.
- Summer school the MOU servicing more than one school--serving a region.
- All people will get the same salery/ the school program, the regional program...Make sure you have a paper stating you have the job and the salary.
- New Committees are set for two years.
