If I'm being honest, I never fully understood why the term "brothers and sisters" was always used in our union notices. It always felt just a little odd to me.

This year I became a delegate for our union. This summer, I joined nine other members, including our President and Vice President, on a trip to the AFT TEACH Conference in Washington DC. Admittedly, when I first arrived at the airport, I felt the same nervousness as when I started at a high school outside of my hometown. I had never met most of the "brothers and sisters" I was about to spend a great deal of time with in a city I've never visited.

Our group attended a wide variety of sessions ranging from combating systemic racism that is inherently intertwined in our lives, to the use of AI in the classroom, to preventing school violence. The school psychologist in me is always on the lookout for trends and patterns. Without fault, any time that

our group would debrief about the different sessions we attended, it seemed we were always discussing how we could bring the information back to our respective schools, identifying the different needs of each school, and where and how the information would fit best.

This was my first sudden insight into the words "brothers and sisters". We are one of the largest school districts spanning across the varied landscapes of CT and have more than 1,200 members in our union. That is a lot of very diverse needs. But those needs were heard, noted, and the first thought when learning new information. This is what a team feels like.

Outside of the sessions, it took no time at all to feel comfortable with these people who were complete strangers just a day earlier. It was fast comradery founded in a curiosity to learn more, an eagerness to do better, and a shared goal for the well-being of our staff and students. This is what a family feels like.

I no longer wonder why we use the words "sisters and brothers" when referring to our membership.

It just makes sense.

#### **Important Reminders**

**Advanced Degree Stipend** Sign Up is open until October 15th. Please read the email from Carla Keilbasinski that was sent to your work email. You can also use the flow chart on our website and on our Facebook page as a resource. If you are already receiving Advanced Degree Stipend for your highest degree, you do not need to apply again.

**Sick Bank Enrollment** is open from September 1st to November 1st every year. The enrollment form is available on our website. You must be a full time employee for three years or a part time employee for three years and 66 days to enroll. Your building reps will have a list of who is eligible to enroll. If you have enrolled in the past, you do not need to enroll again.

#### Your Union Rights During an Investigation

Bob Riccitelli is SVFT's Executive Union Representative. He is a Sustainable Architecture Department Head from Platt. He is also an alum of our district.

If an administrator calls you into their office and starts asking you questions about an incident about you or a colleague, you have the right to stop that meeting and ask for union representation. You can do this at any point during any meeting. It is in your best interest to have a union representative present in case the issue goes to Labor Relations.

Usually your building representative will be your rep, but if it is a matter between two SVFT members, a FT officer will represent you. The representative is not there to defend anyone's actions or to talk on your behalf but rather to document the conversation, list documents or evidence provided in that meeting, and give you someone to talk to if you're not sure how to answer. Occasionally an administrator will ask questions that are not appropriate to an investigation or may become unprofessional in their questioning. In that case, a rep may intervene and/or end the interview. At that point, I would get involved. Without proper documentation, it becomes very hard to defend you in a pre-disciplinary hearing.

So please don't ever think that a casual conversation with your school administrator cannot be stopped if it seems to be leading towards an investigation. ASK FOR YOUR REP. It is your right.

In June we had elections for building representatives and our Executive Council voted on our committee members and delegates. We would like to thank everyone who served last term and those who will be serving this term. We received over 40 requests to join committees and worked to ensure that everyone who wanted to serve the union would be offered a committee seat. Our goal as officers was to offer a slate of committee members that was diverse in many different ways and also gave an opportunity for new volunteers. If you are interested in joining a committee, the next opportunity will be in Spring 2025.

#### Our Executive Council is made up of our five officers and our 37 building representatives.


Your building representative is your liaison to the officers and also your building administration.

#### Labor Unions Are Not The Only Unions To Look Out For

Jessica Stamp is a Science Teacher at Platt Technical High School. She is also a leader of the Blake Street Tenants Union (BSTU).

Dear Brothers and Sisters,

There is a housing crisis in CT. Over 40% of renters are cost burdened, meaning they pay more than 30% of their income in rent each month. They often must choose between groceries or medicine or heat for their family.

At the same time, corporate megalandlords are moving into the state and buying up property for the sole purpose of maximizing profits. They "renovate" with a coat of paint and crooked tiles, calling it luxury. In my complex, an apartment with a rent set at \$1100 was increased to \$1900 when it was "renovated." My neighbors can't afford that, and we can't afford to move either. Rent is too high everywhere.

These megalandlords also buy up low income homes and choose not to invest in them. The buildings decay leading to health problems from rodents and mold. Many apartments are at risk for fires. The most vulnerable amongst us live in these homes because it's all they can afford, including many of my students. No one deserves to live without dignity.

When my megalandlord, Ocean Management, bought our complex, maintenance issues and phone calls were ignored. My neighbors were left without heat, with raw sewage backing up into their bathtubs, and with rusted nails and razors from

renovations causing flat tires in the parking lots. So, we formed the Blake Street Tenants Union (BSTU). We are the first municipally recognized tenants union in the state.

In June, Ocean gave us a 30% rent increase that would have hurt many of my neighbors. So we refused it, standing together in solidarity and demanding to collectively bargain.

On August 19th, we received 16 retaliatory notices-to-quit, promising evictions if we didn't move out by September 1st. My landlord admitted they did it to scare us, so we would call and sign onto the new lease with the higher rent. But we weren't scared.

On August 30th, we marched. Labor unions, elected officials, and faith leaders - around 400 people marched with us in solidarity because the same people that don't want to pay us for the true value of our work are also trying to take as much of our paychecks as possible to profit off our rent.

After the publicity, the support from elected officials, the size of our march, and the threat of a lawsuit, on September 5th, my landlord rescinded the notices-to-quit, formally recognized our union by naming us on a legal document, and agreed to enter negotiations for a collective bargain. This is a first in CT's history and it's very, very exciting!

We haven't won everything we want yet, but we are standing together in solidarity. I would like to invite you to join our movement. With a union at home and a union at work, together, we can start to hold negligent landlords accountable and we can keep rent reasonable.


