The Governor appointed Dr. Alice Pritchard as the Interim Executive Director, I just reached out to her to set up a meeting. The Superintendent posting closed with 34 applicants. Makenzi and I traveled to TRUMPF Inc. last week in Farmington to meet with Dr. Christine Benz, our new Board Chair. We shared our concern that, with the last chair leaving, for the first time there are no former educators on the Board. We are looking for a way to change that. We also met with our lawyer and negotiating chair Bob Herdlein to lay out the schedule for negotiations.

year, and rightfully so. Here at the union office, we are seeing a huge uptick on member-on-member complaints. As a union we stand strongest when we stand together. We will try to mediate ourselves before it rises to the level of HR involvement, but only if we're asked.
