- Q - Can Union Reps get released to attend the Health and Safety meetings?  
A - It is up to the building principal. In our contract it is only the Safety Committee, but we can ask. If you have a specific list of areas we should visit please provide that ahead of time.

### **Makenzi Hurtado President's Report:**

#### **SEBAC**

The Governor did put out his proposed budget. In the proposal there is \$1.2 million for 36 para educators to be hired for next school year, \$1.5 million for Adult Education and \$5 million for increased utilities costs. This is a proposed budget, it will still have to be voted on. We intend to bargain for the SVFT to represent all para educators that are hired by the district.

#### **Negotiations Updates**

We had a negotiation session on January 21 and met as a committee on January 28. We had a session planned for February 2, but it was cancelled. We have another session planned for February 24 and will schedule March dates. We are confident that we will complete negotiations in time for the General Assembly to vote.

We will not declare impasse unless we are unable to negotiate further. We do not want to go to arbitration on issues that we are able to negotiate.

#### **Legislative Session**

The new legislative session began today. I will be spending much of my time lobbying for SVFT and State Employees. I attended a meeting with the Blue-Collar Caucus on Sunday night and also have meetings scheduled with the Governor and leadership. We are advocating for a fair State budget, contracts, funding for CTECS, special education reform, and many other bills.

There will be opportunities for members to testify and AFTCT will be hosting training sessions for people to learn how to testify.

AFCT also hosts Legislative meetings. These are local meetings with your senators and representatives where we get to speak directly in an informal setting (like speed dating) on our issues.

## **Miscellaneous**

Jamie Lamitie continues to offer The First Cut Forum sessions for new trade teachers. These are great virtual meetings for trade teachers that have questions and need support or guidance on anything. The next session is February 9 and the theme is A. I. Resources. Jamie will be sharing some great resources, but we also welcome other teachers to share what they are doing. While we usually focus on new trade teachers, we believe this session will be helpful to all teachers.

## **Organizing Training**

We had our first organizing training on January 24. It was a great training, but more importantly, we spent a good amount of time discussing areas where our union can grow and strengthen. One area that we discussed was the 10:1 ratio of leader to member. We have great member density, but our goal is to have more active members. We are going to be working on identifying and reaching out to members who would like to be more active members at the building level or larger union level. If you are aware of people that you think would be good building leaders, please let me know. We will be planning more organizing training and I do hope that more building reps will attend the next ones.

## **Union Leadership**

Now that we will have a full team of officers, we will spend some time reviewing our roles and responsibilities, as well as the roles and responsibilities of our building representatives. We will also be working on our goals and strategic plan for the rest of this year and term. We are hoping to have our new officer on release by the end of the month.

## **Questions for President:**

- Q – Teacher evaluation items that were brought back in seem to be a bit subjective and troublesome.  
A - Those items were always going to be brought back in. They decided to not have those items in the evaluation in the first year.
- Q - Do you anticipate anything else being added to the evaluation next year?  
A - No, I have not heard any feedback about the evaluation. There might be a change to some of the forms but I don't think there will be any more components.

- Q - There have been some political changes and we usually back Democrats, but the Democrats don't always come through for us.  
A - If there is a Republican candidate that would like to sit down and talk with us we would be all ears. The AFL/CIO just endorsed their first Republican State Rep. Based on his voting record I think they will continue to support him. We as the SVFT do not endorse anyone. Most State Reps and Senators that are Republican propose budgets where we take nothing but zeros and want to get rid of collective bargaining. We would not support that.
- Q - General Membership meetings at new locations? The attendance has been pretty low.  
A - Yes, we are trying to have one at Platt this year. We are hopeful there will be a better turnout. Some schools don't have the space to fit everyone, so some of the schools that would be a good location there isn't a room in that building that can accommodate the meeting.
- Q - Did another union come to an agreement?  
A - Yes, there are about 6 unions that have tentative agreements. One of them should be voting on it soon or already has.

#### **Union Business:**

- Q - Sick bank. I have a teacher that is out of sick time and waiting for a response from sick bank  
A - Have them call me or Bob.
- Q - Any update on our HVAC guy. Do we know if he is coming back?  
A - I don't have an official word yet.
